It is my great honor to share Hawai'i Foodbank's 2021 Annual Report with you. I've now been with the Foodbank for nearly a year, and I can honestly say that this work has been the most fulfilling and rewarding of my life. I'm truly privileged to be part of such an incredible network of people wholly dedicated to ensuring no one in our community goes hungry.

The COVID-19 pandemic presented extraordinary challenges to Hawai'i, and Hawai'i Foodbank responded – as our mission affirms – with integrity, humanity and aloha. Our tireless staff and volunteers worked closely with our network of more than 200 food partner agencies to provide food for people affected by the pandemic, while continuing to meet the nutritional needs of those who were already struggling with hunger. Together, we provided food for nearly 20 million meals last year – about twice as much food as prior to the pandemic.

And yet, food insecurity remains a grave issue in Hawai'i. 1 in 6 Hawai'i residents will struggle with hunger this year, including 82,000 children. That's approximately 1 in 4 keiki who may go to bed hungry, or whose parents or grandparents will choose to go without so that their keiki can eat. Here in Hawai'i, we have the second highest rate of child food insecurity in the United States. I know this is as unacceptable to you as it is to me. Consistent access to quality, nutritious food is a fundamental human right, and we are committed to ensuring that everyone we serve has the nourishment they need to grow and thrive.

At Hawai'i Foodbank, we are working to establish long-term food security for our communities by building and strengthening partnerships; growing our network of support; and investing in programs that provide nutritious food to keiki, families and seniors. Inside these pages, you'll read about our Food 4 Keiki School Pantry program, which provides young students, their siblings and their families with healthy snacks during the day, as well as additional family food bags to take home each week. Our kūpuna programs provide monthly food boxes and farmers' market vouchers to seniors who need assistance. Last year, nearly a quarter of the food we distributed was fresh, healthy produce, and we've expanded our partnership with the Hawai'i Farm Bureau piloted at the beginning of the pandemic to provide local produce and proteins to those we serve. We're proud to share our programs with you, and are grateful to the many supporters, volunteers, funders and staff who came together to make this all possible.

With your continued support, we can help families achieve long-term food security. Mahalo for your partnership in our mission to ensure no one in our 'ohana goes hungry.

ABOUT HAWAI‘I FOODBANK

Hawai‘i Foodbank is a non-profit 501(c)3 agency that provides food assistance to the state of Hawai‘i. We serve O‘ahu and Kaua‘i directly while partnering with The Food Basket to serve Hawai‘i County and Maui Food Bank to serve Maui County. Together, we work to ensure that no one in our Hawai‘i ‘ohana goes hungry.

As Hawai‘i’s leading hunger-relief organization, Hawai‘i Foodbank distributed nearly **25 million pounds of food**, including nearly **5.3 million pounds of fresh produce**, on O‘ahu and Kaua‘i in 2021.

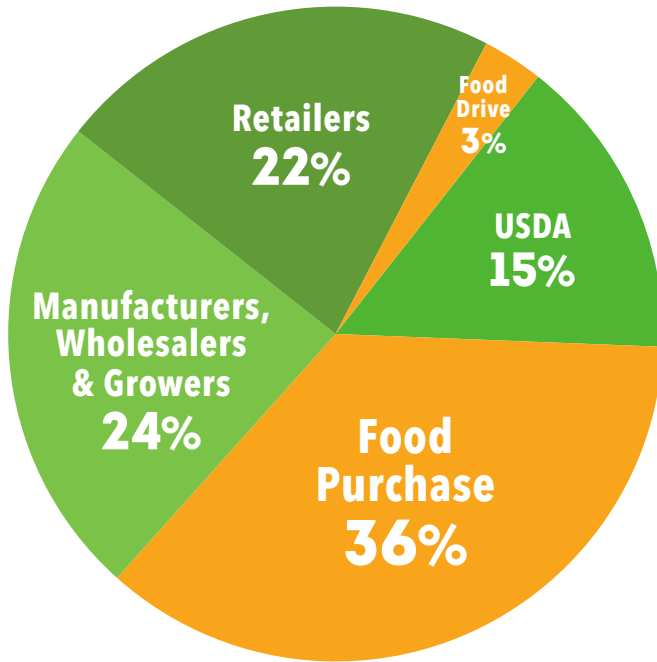

FLOW OF FOOD



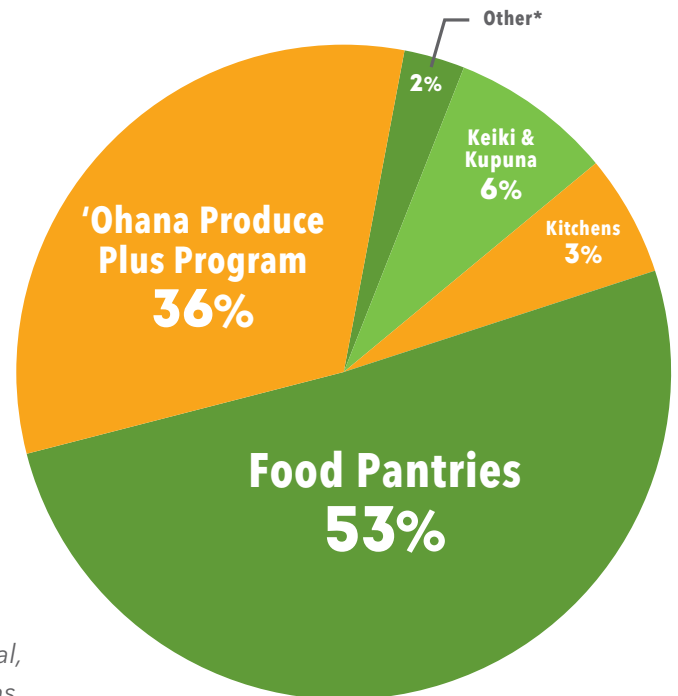
SOURCES OF FOOD

Hawai'i Foodbank operates out of two locations: our 23,668 square-foot warehouse on O'ahu and our 4,750 square-foot warehouse on Kaua'i. Both warehouses are AIB inspected and certified for food safety. In our warehouses – we receive, inspect, sort, inventory, store, and distribute perishable and non-perishable food.

We receive food from food manufacturers and growers, food purchases, food retailers and wholesalers, Feeding America, individual and corporate food drives, and federal food commodities.

DISTRIBUTION OF FOOD

Hawai'i Foodbank partners with food pantries, homeless shelters, soup kitchens, domestic abuse shelters, rehabilitation centers and others to distribute food through feeding programs like the following: 'Ohana Produce Plus, multiple Food 4 Keiki programs, the Senior Farmers' Market Nutrition Program and the Senior Food Box Program.

HUNGER *touches* EVERYONE

As the COVID-19 pandemic continues to affect our communities, those who struggle with hunger find themselves in a particularly vulnerable situation.

Now, nearly a quarter of a million Hawai'i residents are currently struggling with hunger. Among them are out-of-work parents, a growing number of kūpuna and 1 in 4 keiki.



The Ongoing **NEED**

Supply chain issues and higher grocery prices are forcing many individuals and families in Hawai'i to make difficult choices in order to cope with hunger. This means opting in for cheaper, unhealthier food options and skipping meals. To get by, many even forego essential needs like housing, medicine, utilities, education and transportation.

Hawai'i Foodbank is here to help. It is our mission to ensure every member of our 'ohana has the nourishment they

need. We work closely with our **network of more than 200 food partner agencies** to provide food for families affected by the pandemic, while continuing to provide assistance to those who were already struggling with hunger.

1 in 6 residents will likely struggle with hunger this year. This includes **more than 82,000** keiki in Hawai'i, who are now among the hardest hit populations in the entire country.

NOURISH



'OHANA PRODUCE PLUS

For more than 20 years, Hawai'i Foodbank and participating food partner agencies have distributed millions of pounds of fresh produce, assorted dry goods and non-perishable food items to under-served communities through the 'Ohana Produce Plus program. Recipients of this program include families with low income, individuals with disabilities, the homeless, working poor and more. For many people, 'Ohana Produce Plus is their only source of fresh fruits and vegetables.

Last year, Hawai'i Foodbank worked with 32 food partner agencies on O'ahu to distribute more than 3.6 million pounds of fresh produce and nearly 5.1 million pounds of baked goods, dairy products, eggs, cereal, snacks, beverages, canned goods and other items.

SCHOOL PANTRY PROGRAM

The Food 4 Keiki School Pantry program serves as a critical food resource for young students, their siblings and their families. The School Pantries provide after-school snacks for young students, as well as additional family food bags to take home. Bags are filled with canned proteins, canned meals, dry goods, snacks and more.

In 2021, we worked to revitalize our Food 4 Keiki School Pantry program, which faced some obstacles as a result of school closures during the pandemic. With in-person learning resuming at many schools last year, we were able to distribute food through a total of 23 School Pantry sites – 15 on O'ahu and eight on Kaua'i. Throughout the 2020-2021 school year, the School Pantry program distributed food for nearly 260,000 meals to more than 59,000 students and their families on both islands.

FEEDING OUR FUTURE

Feeding Our Future is a summer lunch program for children at risk of hunger. Hot lunches were distributed by our food partner agencies, including the Boys & Girls Club of Hawai'i, Hawai'i Community Action Program, Institute for Human Services, Kōkua Kalihi Valley and Mutual Housing Association of Hawai'i.

Last summer, Feeding Our Future distributed 6,815 meals to hungry keiki.

SENIOR FARMERS' MARKET NUTRITION PROGRAM

The Senior Farmers' Market Nutrition Program provides low-income seniors with greater access to fresh fruits and vegetables. Program participants can redeem vouchers for items like fresh produce, herbs and honey at participating Farmers' Market vendors. This program is provided in partnership with the State of State of Hawai'i and the Office of Community Services.

From April to October 2021, the Senior Farmers' Market Nutrition Program served 6,432 certified participants on O'ahu and Kaua'i. Each senior received \$50 worth of vouchers.



SENIOR FOOD BOX PROGRAM

The Senior Food Box Program, otherwise known as the Commodity Supplemental Food Program, distributes food boxes to improve the health and mental status of seniors with low income. Boxes contain supplemental foods such as non-fat dry milk, cheese, cereal, juice, peanut butter, rice, canned meat, fruits, vegetables, and more. This program is provided in partnership with the State of Hawai'i and the Office of Community Services.

Last year, the Senior Food Box Program served more than 2,000 qualified seniors. A total of 25,088 senior food boxes were distributed on O'ahu and Kaua'i.



BUILDING PARTNERSHIPS AND CREATING NEW INITIATIVES

HAWAI'I FARM BUREAU:

In 2021, Hawai'i Foodbank continued to build upon the success of partnerships launched during the pandemic, like our relationship with Hawai'i Farm Bureau. This collaborative effort helped provide more healthy, nutritious food to local families in need while limiting food waste and supporting the local economy and agriculture. These kinds of initiatives are an important step towards strengthening our food systems and creating a healthier, more resilient Hawai'i.

KŪPUNA FRESH:

This important partnership helped us launch a new pilot program in 2021 called Kūpuna Fresh. This initiative aims to provide more local, fresh produce to seniors in need of food assistance. Taking care of our cherished kūpuna – who have done so much throughout their lives to take care of us – is a major priority for Hawai'i Foodbank.

GOALS AND LONG-TERM PRIORITIES

Hawai'i Foodbank has the potential to emerge from the COVID-19 crisis stronger and even better positioned to meet the evolving needs of our communities. Plans for long-term recovery include:

- Continuing to meet the increasing need, including that of people relying on our support for the very first time.
- Strengthening our programs and establishing new initiatives to provide safety nets for our keiki and kūpuna.
- Piloting new programs to help meet the need of those most disproportionately impacted by the pandemic.
- Updating our strategic plan to further address systemic issues in Hawai'i's communities.
- Expanding our ability to meet the individual needs of each community in Hawai'i.
- Advocating for state and federal support to help food banks and our food partner agencies meet the need.
- Educating the community to share information, advocate and destigmatize hunger.

ACCOUNTABILITY: For its demonstration of strong financial health along with its commitment to accountability and transparency, Hawai'i Foodbank has attained its 12th consecutive four-star rating from non-profit evaluator, Charity Navigator. This is Charity Navigator's highest possible rating, indicating that Hawai'i Foodbank adheres to sector best practices and executes its mission in a financially efficient way.

Nearly every day of the year, our Hawai'i Foodbank volunteers play a vital role in the flow of food that comes through our warehouses. Inside the warehouse, volunteers inspect dry food and produce donations by checking the integrity of food products, sorting categories and boxing items for warehouse storage. This helps prepare food for distribution, so we can get it more efficiently to those in need. Warehouse volunteers also provide important administrative and clerical assistance. Beyond our warehouse walls – volunteers provide valuable support to our food partner agencies, special projects and year-round events.

Amid the COVID-19 pandemic, our volunteers have carried our mission without hesitation. As our operational methods have been forced to evolve, our volunteers have adapted along with us – allowing us to carry out our mission without reprieve. Last year, **our dedicated volunteers on O'ahu and Kaua'i worked 8,462 shifts** – donating their time and energy to help us fulfill our mission. Their steadfast support inspires hope for Hawai'i Foodbank and the communities we serve.

RESPONSE AND RECOVERY

With the ongoing COVID-19 pandemic, the resulting economic downturn and a slew of inclement weather that caused flooding in areas like the North Shore and Waihohonu Stream – hunger on Kaua'i reached some of its highest levels in almost a century.

An entirely new level of need now exists on the Garden Island, and – as learned from previous disasters – the recovery can take years. More than 12,000 Kaua'i residents will likely continue to struggle with hunger. This includes 1 in 4 keiki on Kaua'i.

With these challenges, Hawai'i Foodbank Kaua'i worked hard in 2021 to ensure families, keiki, kūpuna and individuals struggling with hunger received the food they need during this difficult time. Over the

last year, Hawai'i Foodbank Kaua'i's staff, volunteers and food partner agencies have been on the front lines – providing emergency relief and ensuring our communities had the food they need during this difficult time.

In 2021 Hawai'i Foodbank Kaua'i distributed food for more than 1.6 million meals. This included more than 210,000 pounds of fresh produce.

Hawai'i Foodbank Kaua'i will continue working diligently to strengthen its feeding programs, build and nurture community partnerships, and find ways to sustainably plan for the future – all while continuing to respond to the immediate, ongoing needs throughout the community.

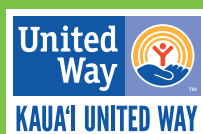
